OFFICERS' MEADOW, NORTH OF SHENFIELD HYBRID PLANNING APPLICATION

On behalf of Croudace Homes Ltd, I am delighted to submit a hybrid planning application for development at Officers' Meadow, north of Shenfield.

I can confirm we have submitted via the Planning Portal, as agreed, using the full planning application form, whilst detailing the description that the application is hybrid. As part of this process, we will pay the fee for the full element of the application (£63,495 + £64 Planning Portal admin). Once submitted, we will send (via BACS) the fee for the outline element of the application (£9,766) based on 2.1ha of safeguarded land for a school and early years nursery.

The description of development is as follows:

Hybrid planning application for 344 units including 35% affordable housing, safeguarded land for a 2FE primary school and early years facility, public open space and associated landscaping, drainage and highways infrastructure.

Full planning permission is sought for:

- 344 units including 35% affordable and 5% custom build
- approximately 11 hectares of functional and accessible open space including multiple areas for formalised play
- sustainable and legible movement routes in the form of footpaths and cycle routes
- primary access from the A1023 Chelmsford Road to the west
- secondary accesses from Alexander Lane to the south, and
- all associated landscaping, drainage and highways infrastructure.

Outline planning permission is sought for:

 the safeguarded land for a 2FE primary school and early years facility which is expected to be brought forwarded by Essex County Council
